## SOLBERG® RE-HEALING \*\* FOAM ENVIRONMENTAL WARRANTY

The Solberg Company will warrant to the purchaser of RE-HEALING<sup>™</sup> foam concentrate, that for twenty (20) years after the purchase, whether as part of a foam/water fire protection system or as foam concentrate only, the use of RE-HEALING foam will not be regulated in any way due to the presence of any organohalogens, whether in surfactants, polymers, or any other form. This environmental warranty also includes the provision that SOLBERG RE-HEALING foam concentrate will not be banned by any governmental entity or regulatory body for any of the following environmental issues:

- No Governmental restrictions related to the presence of fluorine
- No persistence in the environment
- No bioaccumulation
- No PFOS or PFOA
- No biodegradation into PFOS or PFOA

Should environmental regulations enacted after the purchase of SOLBERG RE-HEALING foam require removal of the RE-HEALING foam concentrate from the market for one of these environmental issues, Solberg will replace the RE-HEALING foam concentrate with a new foam concentrate that meets such newly enacted environmental regulations.

In order to be eligible for this warranty, the original purchaser must maintain a semi-annual service agreement using an authorized Solberg channel partner, and must also provide RE-HEALING foam concentrate samples on an annual basis for laboratory analysis as required by NFPA 11 to their regional Solberg factory.

This Warranty will not apply in the event that Solberg determines that there is no fluorine-free foam concentrate available on the market that exceeds the environmental profile of RE-HEALING foam with respect to the environmental issues listed above.

Unless provided by Solberg above or otherwise in writing, SOLBERG DOES NOT WARRANT, WHETHER EXPRESSED OR IMPLIED, THE SUITABILITY OF THE PRODUCT FOR A PARTICULAR PURPOSE. SOLBERG SHALL NOT BE LIABLE FOR CONSEQUENTIAL, INCIDENTAL, SPECIAL OR SIMILAR DAMAGES, NOR WILL SOLBERG BE LIABLE FOR ANY DAMAGES DUE TO DELAY IN REPLACING THE FOAM CONCENTRATE UNDER THIS WARRANTY. SOLBERG'S MAXIMUM LIABILITY UNDER THIS WARRANTY IS LIMITED TO THE REPLACEMENT OF THE FOAM CONCENTRATE.

This Warranty applies to the original purchaser of the original RE-HEALING foam concentrate and is not transferrable.

THIS WARRANTY IS NOT EFFECTIVE UNLESS PAGE #2 WARRANTY FORM IS FILLED IN, SIGNED AND RETURNED TO SOLBERG WITHIN TEN DAYS OF THE PURCHASE OF THE RE-HEALING FOAM CONCENTRATE. FAILURE TO COMPLETELY FILL OUT THIS CARD AND RETURN THE FORM WITHIN THE STATED TIME PERIOD WILL INVALIDATE THE RE-HEALING FOAM ENVIRONMENTAL WARRANTY.
